## 2. ENTRIES

- 2.1. Entry is open only to Eligible Residents who satisfy the Method of Entry during the Entry Period (Valid Entrant).
- 2.2. Entrants may submit up to the Maximum Entries (if applicable).

- 2.3. The directors, management and employees of the Promoter or franchisees (and their immediate families), its related entities or related bodies corporate are ineligible to enter.
- 2.4. The Promoter will not advise an Entrant on the validity of their entry. - 2.6. The promoter reserves the right to validate and check the authenticity of Valid Entries and Entrant details (including identity and age). If an Entrant cannot provide suitable proof, the Entrant will forfeit the Prize in whole.

## 3. PRIZE

## 5. FURTHER DETERMINATION

- 5.2.
